PARTICIPANT AGREEMENT, RELEASE AND ASSUMPTION OF RISK

In consideration of the services of Rev. Connie Habash and Subud House, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf, I hereby agree to release, indemnify, and discharge Rev. Connie L. Habash and Subud House, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows: 1. I acknowledge that my participation in outdoor based activities such as hiking and other physical activities such as yoga entail known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. 2. I expressly agree and promise to accept and assume all of the risks for myself existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks. 3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Rev. Connie L. Habash and Subud House from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of Rev. Connie Habash and Subud House's equipment or facilities, including any such claims which allege negligent acts or omissions of Rev. Connie Habash and Subud House. 4. Should Rev. Connie Habash and Subud House or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs. 5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have. 6. In the event that I file a lawsuit against Rev. Connie Habash and Subud House, I agree to do so solely in the state of California, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect. By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against Rev. Connie Habash and Subud House on the basis of any claim from which I have released them herein. *

1-Day retreat CANCELLATION POLICY: Cancellations made 3 weeks in advance of the retreat receive a full refund. Cancellations after 3 weeks before the retreat, up to 7 days before the retreat, receive a 50% refund. Cancellations 7 days before the retreat or less will receive a 50% credit towards another retreat, if used within one year. After one year, the credit is void.
